When selected as Vice Chair in 2023, I emphasized the following three points.

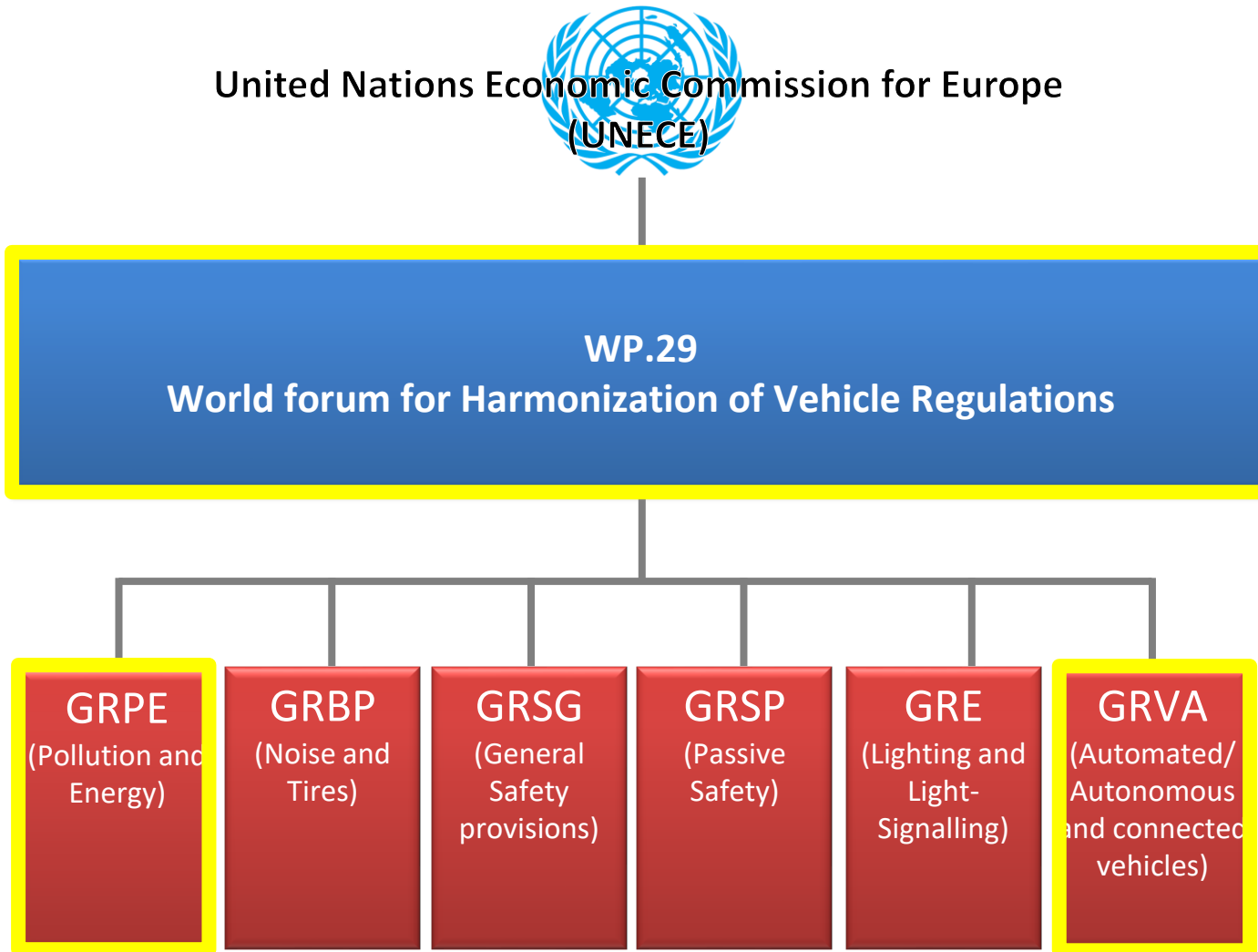
- ① Promote vehicle safety measures that are fair to all, including children and the elderly

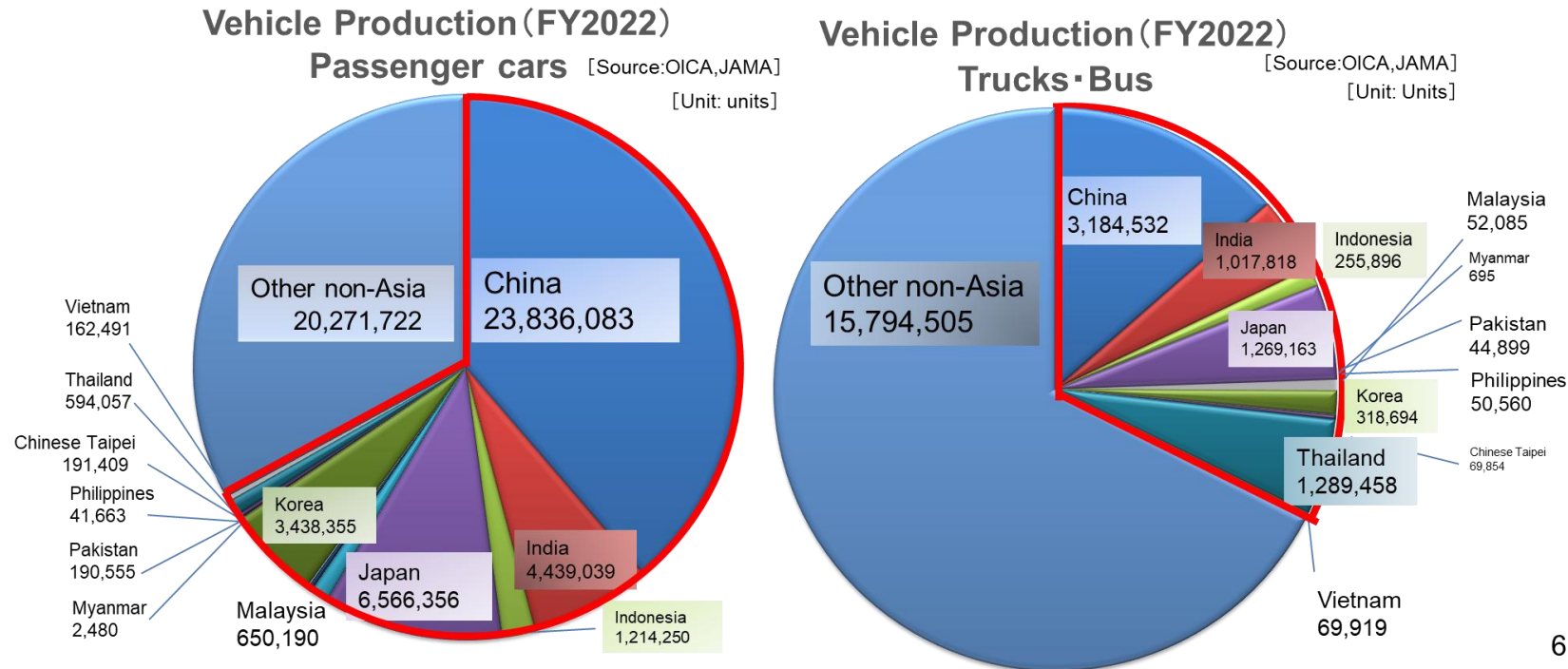

Asia have big impact for world automobile area. Some statics say that

- **Safety:** The number of road traffic fatalities is **more than** half in the world.
- **Environment:** CO₂ emissions in automotive area are **more than 1/3** of the world's total.
- **Automobile industry:** As for passenger car production, it accounts for **about 2/3** of the world's total !



- **Asia has huge impact** to global automobile situation
- However, have we conveyed our voice to WP.29 effectively?

- This can be an initial best practice for the “Asian One Voice”.



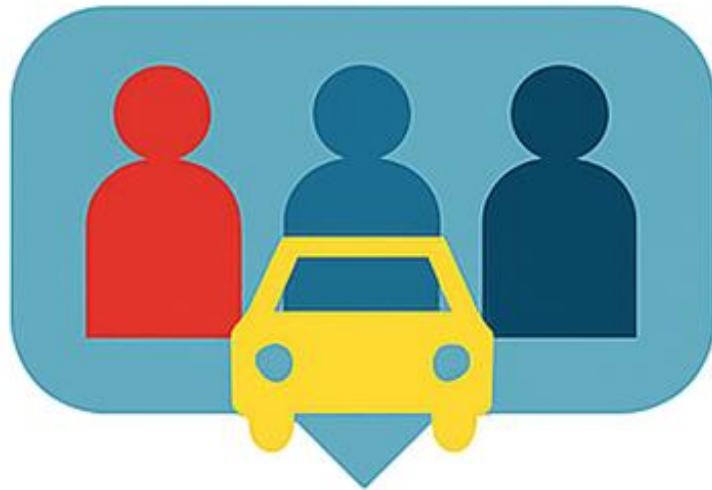
