


-Transition of Japanese type approval regulation-












-Three major concerns for type approval system-









Industry is concerned that multiple requirements for one product will increase the administrative costs.



5-1. Establishment of multiple technical requirements






Industry can manufacture the products to common global specifications, if each country will develop technical requirements based on international standards such as UNR.




5-2. Establishment of type approval systems in each country



The industry can reduce burden to obtain certification! This can be passed on to the development of safer products and making vehicles of accessible price.




5-3. Duplicate Authentication for the Same Component



Industry can use the same type approval for vehicle installation and for sale as a stand-alone product.

Progress to the United Nations 1958 Agreement





- Harmonization of international standards (Unification of technical requirements)
- Mutual recognition of certification system (Unification of certificates)
- Permitted the selection of UN-R old series
- Increased voting rights approval rate $2/3 \rightarrow 4/5$


